To update about the status of implementation of National Education Policy (NEP) Credit Framework and Examination.

The Principal informed that the college has started implementing NEP Credit framework as per the UGC and Government of Maharashtra Guidelines. Students have selected Major, Minor and Open Electives as per their own preference. The College has well curated vocational and skill based courses so as to match the domain knowledge. The student will acquire from their selected disciplines. The College ran generic IKS in First Semester and VEC in both the semester for all the faculties. Considering the workload the Science faculty opted Minor vertical in Semester I. He also informed that the first end semester exams under NEP have been conducted in the month of December.

A possibility was discussed that if a backlog / year down student of an Autonomous Course seeks admission in the Second Year of NEP, it may create an issue of equivalence as the course structure is different for Autonomous system than NEP credit framework. Prof.Dr. Rajeshwari Deshpande suggested that teaching can be continued as per NEP pattern in which such students will selecte Major and Minor courses. While separate exams will conducted for regular students and above mentioned backlog students so that equivalence can be achieved.

4. Approval for lateral entry at Second Year under NEP and to discuss equivalence

In case of lateral entry at Second Year, such students can be given admissions, provided they do the credit compliance. If required bridge courses can be organized by the College for facilitating learning of newly admitted students.

5. Approval for starting New UG Programs -

- B.Sc. (Data Science)
- Bachelor of Accounting and Finance / B.Com. (Accounting and Finance)
- PG Diploma in Mental Health Care

Considering the expertise available in the college and the demand for such courses in the market, the college has proposed new UG Programs viz. B.Sc. (Data Science) and Bachelor of Accounting and Finance / B.Com. (Accounting and Finance) and PG Diploma in Mental Health Care.

Structure of the Course and curriculum were presented by Dr.Dipali Meher (B.Sc.Data Science), Dr.Shubhngi Joshi (Bachelor of Accounting and Finance), Dr.Sadahana Natu (PG Diploma in Mental Health Care).

The council gave unanimous sanction to start the courses and approved the curriculum. The Council recommended that credits of PG Diploma in Mental Health Care need to be 44 credits so as to align it with the curricular framework. Dr. Sanjay Kharat, Principal requested Dr. Jyotsna Ekbote Madam

to get approval for such new programs from the Senate. Madam suggested that such proposal need to be approved by Academic Council of SPPU.

From Academic Year 2024-25 UG courses such as of BBA (CA) and BCA (Science) are required to take AICTE approval. This exercise of getting additional approval will be counter productive as AICTE norms which are originally meant for technical institution will be difficult to adhere to for colleges offering traditional courses, managed with shared resources. Dr. Sanjay Kharat, Principal suggested that BCA (Science) program would be renamed as B.Sc. (Computer Application). He also informed that a Writ Petition has been submitted in the High Court. Result of the same is awaited.

Assigning the credits to different courses designed / conducted / assessed by External Academic
/ Private Institutions and Awarding the Credits and also proposing Credits for modules under
twinning programs / courses.

It was discussed that students will be encourage to join / undertake extra credit courses, additional courses run by SWAYAM and/or NPTEL. As the credentials, services, assessment pattern, curriculum differ with private institutes, let us confine to UGC approved courses run by recognized institutions.

- 7. Approval for guidelines and curriculum of Physical Education Yoga (2 Credits) per Semester Structure of the Course and curriculum of Physical Education Power Yoga was presented by Dr. Dipak Shendkar, Physical Education Director. He informed that under NEP 2020 structure, the number of admitted students for Co-Curricular activity (CC) is very high. Objectives, structure, curriculum and learning outcomes of Physical Education Power Yoga were approved unanimously.
- To Release a Booklet of Second Year Undergraduate and Postgraduate curriculum designed by different BOS under Autonomous College.

The Booklet of curriculum of Second Year Undergraduate and Postgraduate designed by different BOS under Autonomous College was released by the Council members. It was suggested to include eligibility, expected outcomes, course attainment and assessment methods along with the curriculum.

- 9. Any other item with the permission of the Chair.
 - 9.1 Introduction of a CC Course on Indian Music: Dr. Varsha Joshi, member informed that a 2 Credit course on Indian music has been designed. The Council approved the same.
 - 9.2 Changing the nomenclature of PG courses based on Specialization

M.Sc. (Chemistry): The College runs 2 divisions of M.Sc. Chemistry. Earlier the specialization was Organic Chemistry however the College proposes to introduce a new specialization as M. Sc.in Forensic Chemistry.

M.Sc. (Zoology): The College under takes M.Sc. Zoology with the specialization in Entomology. Considering the market scenario, the College proposes to start specialization in Fishery Science as well.

M.Sc. (Mathematics): Currently the College runs M.Sc. in Mathematics. It was suggested to introduce a new specialization of Industrial Mathematics at PG level

9.3 Multiple Entry Exit Mechanism:

Issues were discussed related to multiple entry exit mechanism:

To assign CGPA or SGPA as students may leave the program in between: CGPA and not SGPA is to be considered as student is going to re-enter in the education system.





Need clarification from Parent University, Savitribai Phule Pune University about surrendering certificate or diploma if the student exit the program in between and joins again and also clarification about Academic Bank of Credits (ABC).

Generating PRN for College students: As the programs are autonomous, the College is generating PRN for the students. This has created a gap while generating results. The College requires support from SPPU in this regard.

It was resolved that Parent University should support and give approval for the PRN generated by College at the earliest to avoid inconvenience.

The meeting was concluded with the cordial vote of thanks.
