Memorandum of Understanding

These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation, etc.

- Specific procedures, requirements and duties of the parties in connection with student exchanges shall be set forth in a separate written program agreement to be executed by the parties.
- Cooperation and exchanges may take place with post-graduate, PhD students. Each exchange may be for the duration as per requirement.
- If two faculty members from each institution are engaged in collaborative research projects, doctoral students at one institution may visit and work in the lab of the faculty member at the other institution and incorporate the work done as part of their dissertation.

DURATION AND EVALUATION:

- This MoU shall be in effect for a period of Three (03) years from the last date of signature. Either party may request termination of this agreement, in writing, ninety (90) days prior to the proposed termination date.
- Amendments to this MoU may be requested, in writing, by either party and approved by the authorized signatories.
- The parties to this MoU undertake to treat as CONFIDENTIAL AND PRIVILEGED information of the other institution, which is so classified in advance. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.
- This MOU shall be identified as the parent document of any program agreement executed between the parties.

This MoU is signed subject to approval of the respective academic/administrative bodies.
